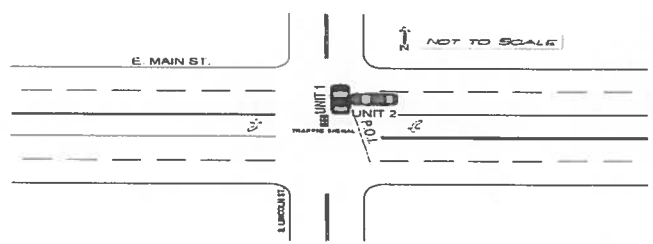
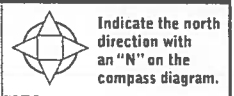

NARRATIVE

Unit 1 was traveling from south to north on Lincoln St. Unit 2 was traveling from east to west on E. Main St. Unit 2 failed to yield to the red traffic light and stuck the passenger side of Unit 1.

The driver of Unit 2 stated that she was looking down at her coffee when the accident occurred.

Kent FD arrived on scene and evaluated both drivers. Both drivers complained of soreness from the seatbelt. The river of unit 2 had a cut about 6"

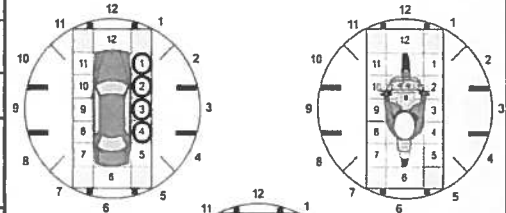

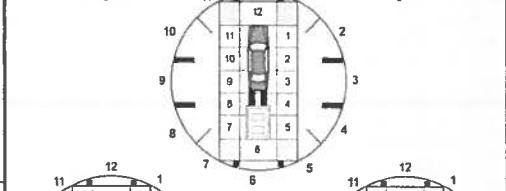

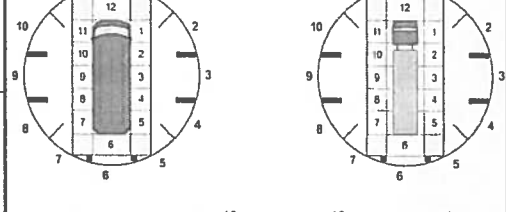


WAS VEHICLE OPERATING IN AUTONOMOUS MODE WHEN CRASH OCCURRED? **2**

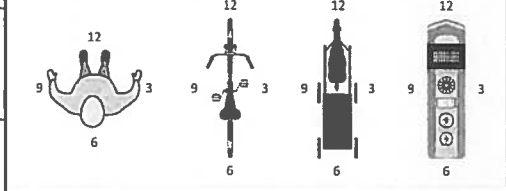
