A RESOLUTION OF COMMENDATION AND APPRECIATION TO THE HONORABLE JOHN KUHAR FOR THE GENEROUS CONTRIBUTION OF HIS TIME AND TALENTS AS WARD 4 COUNCIL FOR THE PAST EIGHTEEN YEARS.
