Finance Committee Items

1. Regional Income Tax Agency Anaylsis

Earlier this year staff presented Council with a proposal to transition from City income tax operations to the services of the Regional Income Tax Agency. Council asked for more information and Barb Rissland provided a staff evaluation comparing the City of Kent income tax operations with the Regional Income Tax Agency in last week's mailing.

Administrative Recommendation

Barb's report includes a thorough review of the background of the Regional Income Tax Agency and the benefits that she believes can be gained both in customer service and in financial collections. Barb believes that making this change can save/generate as much as \$250,000 and offer better, more convenient services for our residents so I would recommend Council give this proposal serious consideration, if even on a trial basis.

Council Action

Review the RITA report and direct staff accordingly.

Information Items

1. Smart Bike Proposal

Kent State University was approached by representatives from Clear Channel to discuss the possibility of adding Kent (and Kent State) to the list of cities that participate in Clear Channel's Smart Bike Program. The Smart Bike program is a bike loan program that makes bicycles available for use all over town at a minimal rate. Clear Channel provides the service at no cost to the City or the University but they do ask to be allowed to advertise at designated locations around the city, e.g., bus shelters, kiosks, etc. Bike loan programs have been very successful in Europe, and we think the idea has merit, but we are still very early in the discussion phases. I just wanted to share some of the information we've received regarding the possible project. (attached)

2. City Financial Notes
