## 1. Kent Police Statistics

Chief Lee has provided a copy of the police statistics report for August 2019. In 2019 calls for service are up $15 \%$ ( 2,941 calls); traffic citations are up $13 \%$ ( 279 tickets); accident incidents are down $2 \%$ ( 7 incidents) and serious crimes are up $8 \%$ ( 32 cases). (attachment)

## 2. Income Tax Report

Dave Coffee has provided a summary of income tax collections thru the end of August 2019. Overall the City income tax collections are up $3.71 \%(\$ 353,996)$ from August 2018. Kent State University's collections thru the end of August are down 1.26\% (\$43,554). (atta chment)

## 3. Notification of Approved Sidewalk Variance Request

As required by City Code, Jennifer Barone has provided a copy of the approved variance request for a portion of proposed sidewalk in front of 1220 Fairview Drive. The request is to eliminate sidewalk on the Fairview Drive frontage. The variance request was approved based on the rural nature of Fairview Drive and the lack of sidewalks to which to connect.
