### 1. City/Portage County Public Defender Contract Renewal (Hope)



### 3. 2022 Budget Appropriations Amendment (Rhonda)

### 4. 2022 "Then and Now" Authorization for the City Audit (Rhonda)

## Information Items

### 1. Income Tax Report

Rhonda Hall has provided a summary of income tax collections for the October of 2022. Overall, the City income tax collections YTD are up 12.3% (\$1,523,202) compared with October of 2021. For the month of October, the City income tax collections are up 30.1% (\$367,696) compared to October 2021. (attachment)

### 2. Fire Incident Reports

Chief Myers has provided a copy of the fire and emergency medical services report for September 2022. In 2022 YTD calls for fire service are up 30.9% (257 calls) for September compared with YTD 2021; fire mutual aid assistance remains up for the YTD by 4 calls (to 12) in 2022 as compared to 2021; and EMS responses are up 6% (165 calls) for June, compared to YTD 2021. ### 3. Kent Police Statistics

Chief Shearer has provided a copy of the police statistics report for October 2022. In 2022 calls for service are down 8.6% (by 174 calls); traffic citations are down 41.2% (91 tickets); accident incidents are down 6.3% (9 incidents) and serious crimes are up by 2 incidents compared to zero in October of 2021.
