Information Items

1. Solar & Wind Energy Grant Update

Bridget Susel has provided an update on her research into the availability of Federal or State grant funds targeted for solar and wind energy projects. According to Bridget's findings, there is nothing imminent that we would appear to qualify for but we will continue to work with our Energy Consultant to pursue possibilities. 2. Monthly Permit and Zoning Reports

Gary Locke has enclosed a copy of the monthly zoning and permit violations report thru August 2009. The total number of permits issued this year is down 8% from last year (thru Aug 31) and the corresponding revenues are down 44% (\$104,000). Troy had 32 action items on his August report, most of which were grass and weed violations, and property maintenance items. In case you had not noticed, the scaffolding that had been a point of frustration on SR43 has finally been removed thanks to the persistence of Troy and Eric Fink. (attachment)

3. Fire Statistics

Chief Williams has forwarded his July 2009 Fire Statistics report. Total calls for service are slightly down for both for fire incidents (-8%) and emergency medical service (-3%). As a reminder, Chief Williams will be out of the office beginning Tuesday, September 8, 2009, at 08:00 for approximately a month due to surgery. During his absence Captain Dave Manthey will be in charge of the fire department. (attachment)

5. NOPEC Electric Budget Billing Information

Gene Roberts has provided additional information from NOPEC concerning electric service available to our residents here in Kent. It appears that there's been some confusion over the issue of budget billing and NOPEC has provided a short summary statement noting that at the moment all discounted supply agreements do <u>not</u> allow for the supply portion of the bill to be done on a budget basis but they are working with their supplier to try to change that in the future.
