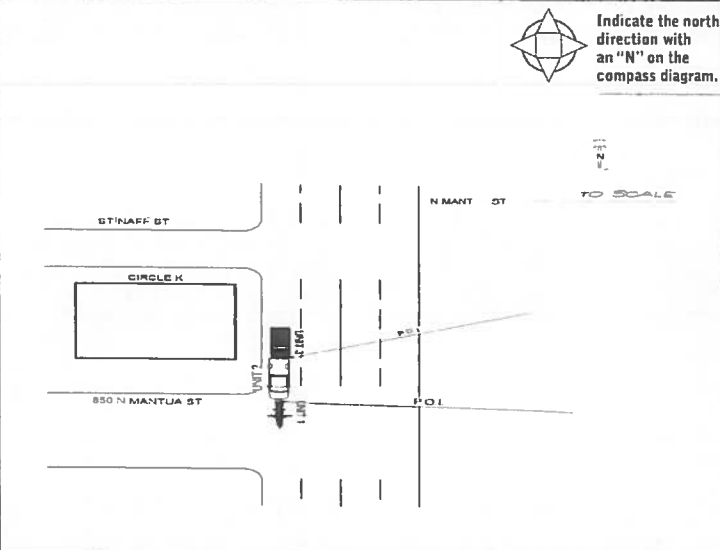

Unit 1 was traveling from North to South on N Mantua St (STHY 43). As Unit 1 slowed to turn west into a business, he was stuck from behind by Unit 2. Unit 3 was traveling too close to Unit 2 and stuck the rear end of the vehicle.
The driver of Unit 1 was thrown from the motorcycle and onto the roadway.
Kent FD EMS arrived on scene and evaluated him. He reported soreness and had an abrasion to his right

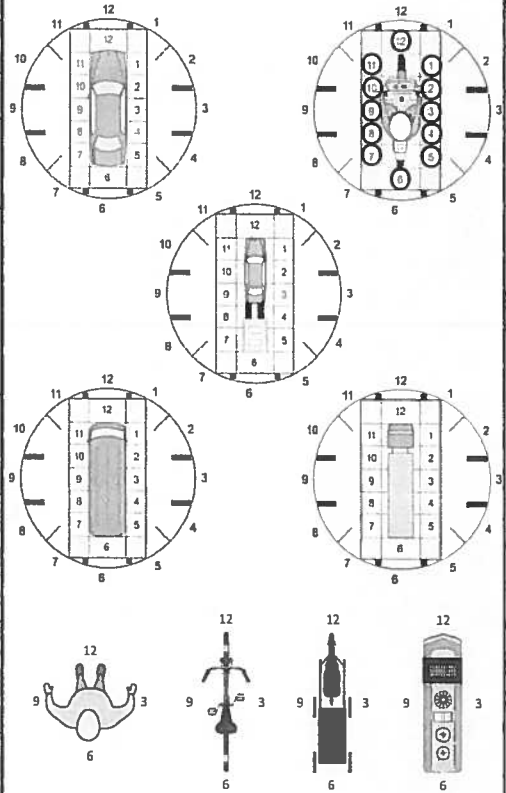

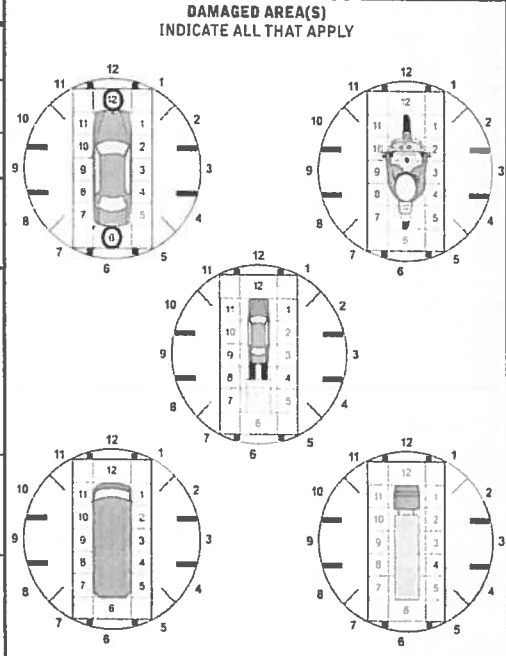

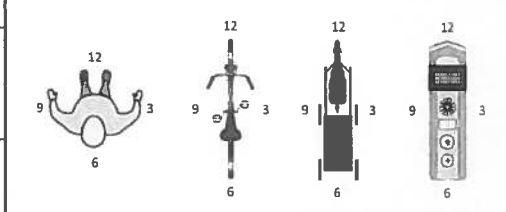


WAS VEHICLE OPERATING IN AUTONOMOUS MODE WHEN CRASH OCCURRED?

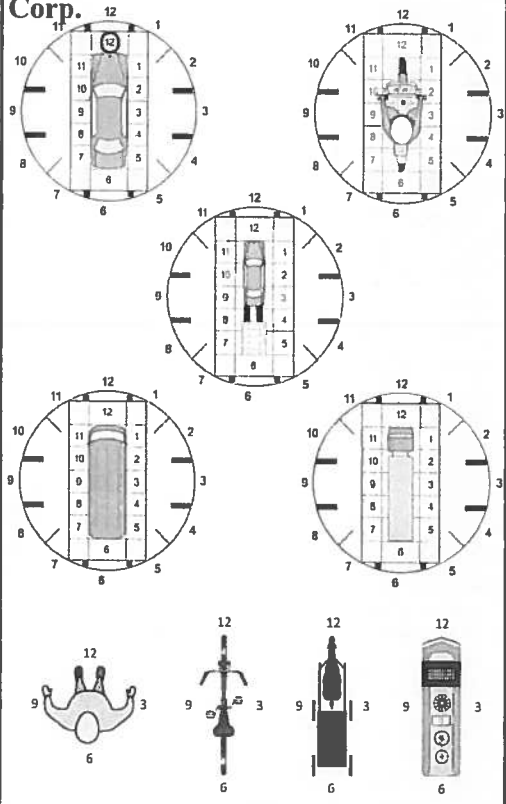
