## **ORDINANCE NO. 2019 - 82**

AN ORDINANCE AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO APPROVE A NEW SPECIAL EVENT APPLICATION FROM THE FAMILY & COMMUNITY SERVICES, INC. FOR THE OPIOID AWARENESS MUSIC FESTIVAL TO BE HELD ON SUNDAY, AUGUST 11, 2019, AND THE TEMPORARY CLOSURE OF NORTH WATER STREET, BETWEEN MAIN STREET AND COLUMBUS STREETS AND WEST MAIN STREET BETWEEN WATER STREET AND FRANKLIN AVENUE, AND DECLARING AN EMERGENCY.

WHEREAS, the Opioid Awareness Music Festival is an event to raise awareness on Opioid addiction and provide information and resources to the community; and

WHEREAS, the organizers would like to temporarily close North Water Street, between Main Street and Columbus Streets and West Main Street between Water Street and Franklin Avenue beginning from Noon on Sunday, August 11, 2019 and continue until 9:00 p.m. that evening; and

**WHEREAS**, the Kent City Council consents to authorizing the City Manager or his designee to sign the Special Event Application as long as he is comfortable and believes the safety and security of the City's citizens will not be adversely affected; and

WHEREAS, the time is of the essence as the event is scheduled for August 11, 2019.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Kent, Portage County, Ohio, at least three-fourths (3/4) of all members elected thereto concurring:

<u>SECTION 1.</u> That the Kent City Council authorizes the City Manager or his designee to execute the Special Event Application from the Family & Community Services, Inc. in substantial conformance with the Special Event Application attached hereto as Exhibit "A", as long as the City Manager or his designee believes the safety and security of Kent's citizens are adequately projected.

**SECTION 2.** That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

**SECTION 3.** That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of the residents of this City, for which reason and other reasons manifest to this Council this Ordinance is hereby declared to be an emergency measure and shall take effect and be in force immediately after passage.
