### 2. Lease for 803 Fairchild

## 3. Portage County Recycling Fee Increase

The Portage County Solid Waste District increased fees for recycling services and has requested Council's adoption of the new fee schedule for Kent business accounts. The proposed recycling fee increases range from \$2 to \$8 more per month. Gene notes that this is the first fee increase since the program began in 2002. (attachment)

Administration Recommendation

Recommend consideration of the request and approval of the fee change.

Council Action

Adopt the new fee schedule.

Discuss neighborhood issues and direct staff accordingly.


