# Information Items

## 1. Executive Team Car Allowance

At Council's request, I have provided an analysis of the use of the car allowance to supplement the top management team's compensation. In comparing our salary rates with our peers, I discovered that we fall below the average pay rates for 7 out of 8 positions compared. By adding the car allowance, we push 5 out of 8 up to, or just above, the regional average. For these reasons, I am recommending continuing to extend the car allowance as a critical piece of our pay and compensation package. (attachment).

## 2. Board of Zoning Appeals Staff Report

#### 4. Kent State Centennial Research Park



In case you missed it in the local press last week, Kent State announced the opening of its new "Centennial Research Park" at the site of the old Kent State bus facility. This is a state of the art facility that accelerates the commercialization of academic research into manufactured products. In the course of our budget discussions, we talked a lot about leveraging university assets into economic development opportunities – and that's exactly what this facility makes possible, so I wanted to be sure you were aware of it and shared my excitement for its potential local impact. I've attached a short press release that describes the facility. Staff has already begun to look at what we could do to expand the incubator/accelerator concept around the new site to begin to create a dynamic research hub that serves as a catalyst for new local business.
