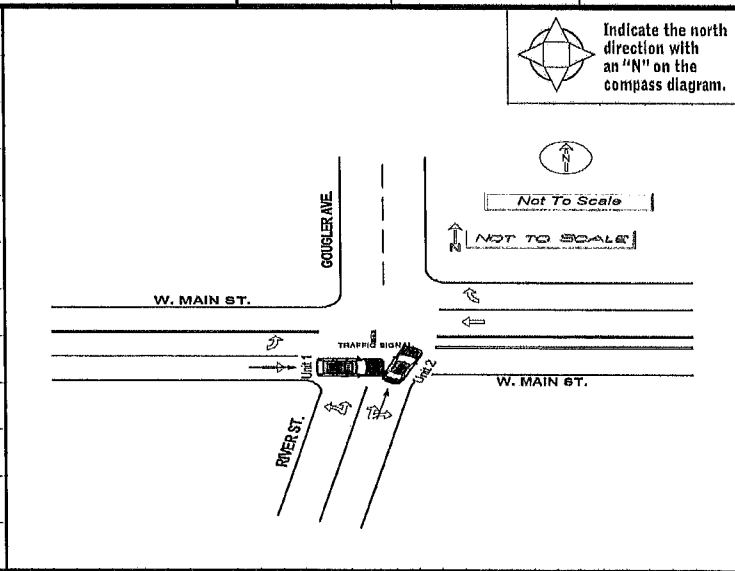
NARRATIVE

Unit 2 said he swerved to miss unit 1, and unit 1



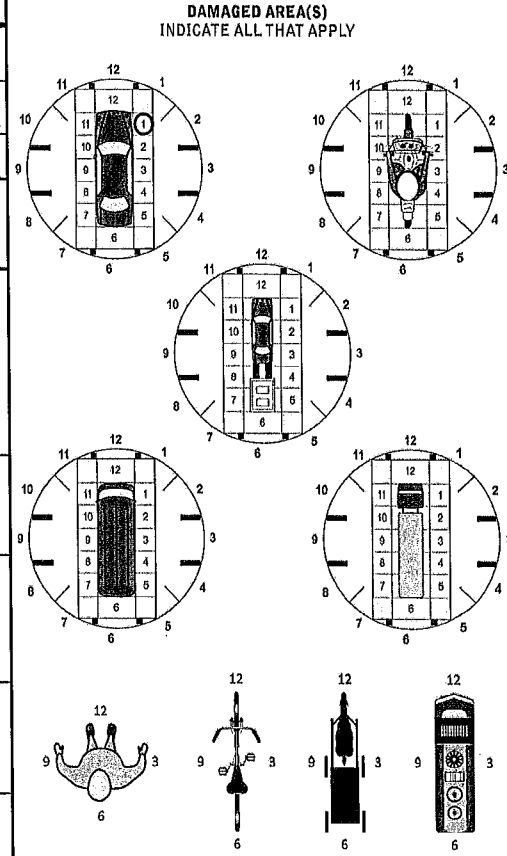

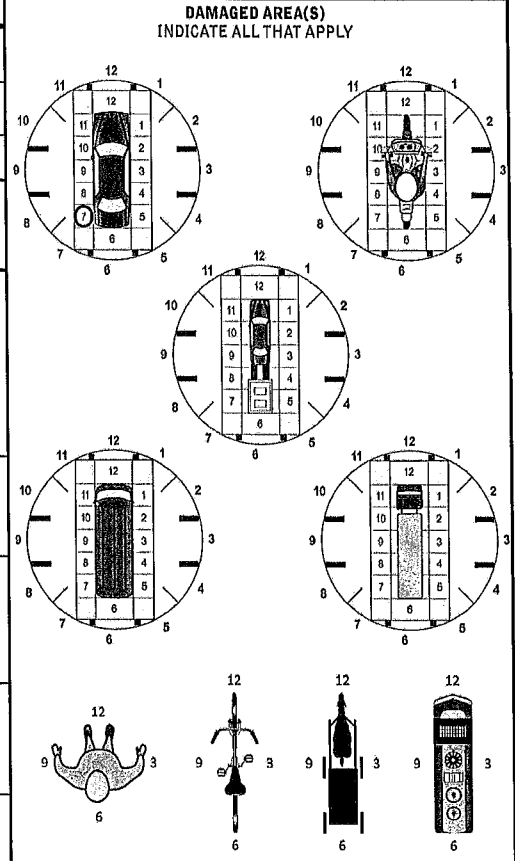
