

ORDINANCE NO. 2023 - 010

AN ORDINANCE AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO APPROVE A NEW SPECIAL EVENT APPLICATION FROM DAVID SCHOEFFLER TO BE HELD ON SATURDAY, JUNE 24 AND SUNDAY JUNE 25, 2023, AND THE TEMPORARY CLOSURE OF ERIE STREET BETWEEN SOUTH DEPEYSTER STREET AND ROUTE 59, AND DECLARING AN EMERGENCY.

WHEREAS, David Schoeffler is requesting a road closure for the Shiva wedding; and

WHEREAS, the wedding will take place Saturday, June 24, 2023 and end Sunday, June 25, 2023. The temporary closure of Erie Street between South Depeyster Street and Route 59 North Water Street will begin Friday, June 23, 2023 for setup and end on Sunday, June 25, 2023 for cleanup; and

WHEREAS, the Kent City Council consents to authorizing the City Manager or his designee to sign the Special Event Application as long as he is comfortable and believes the safety and security of the City's citizens will not be adversely affected.


NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Kent, Portage County, Ohio, that:

SECTION 1. That the Kent City Council authorizes the City Manager or his designee to execute the Special Event Application from David Schoeffler in substantial conformance with the Special Event Application attached hereto as Exhibit "A", as long as the City Manager or his designee believes the safety and security of Kent's citizens are adequately projected.

SECTION 2. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of the residents of this City, for which reason and other reasons manifest to this Council this Ordinance is hereby declared to be an emergency measure and shall take effect and be in force immediately after passage.

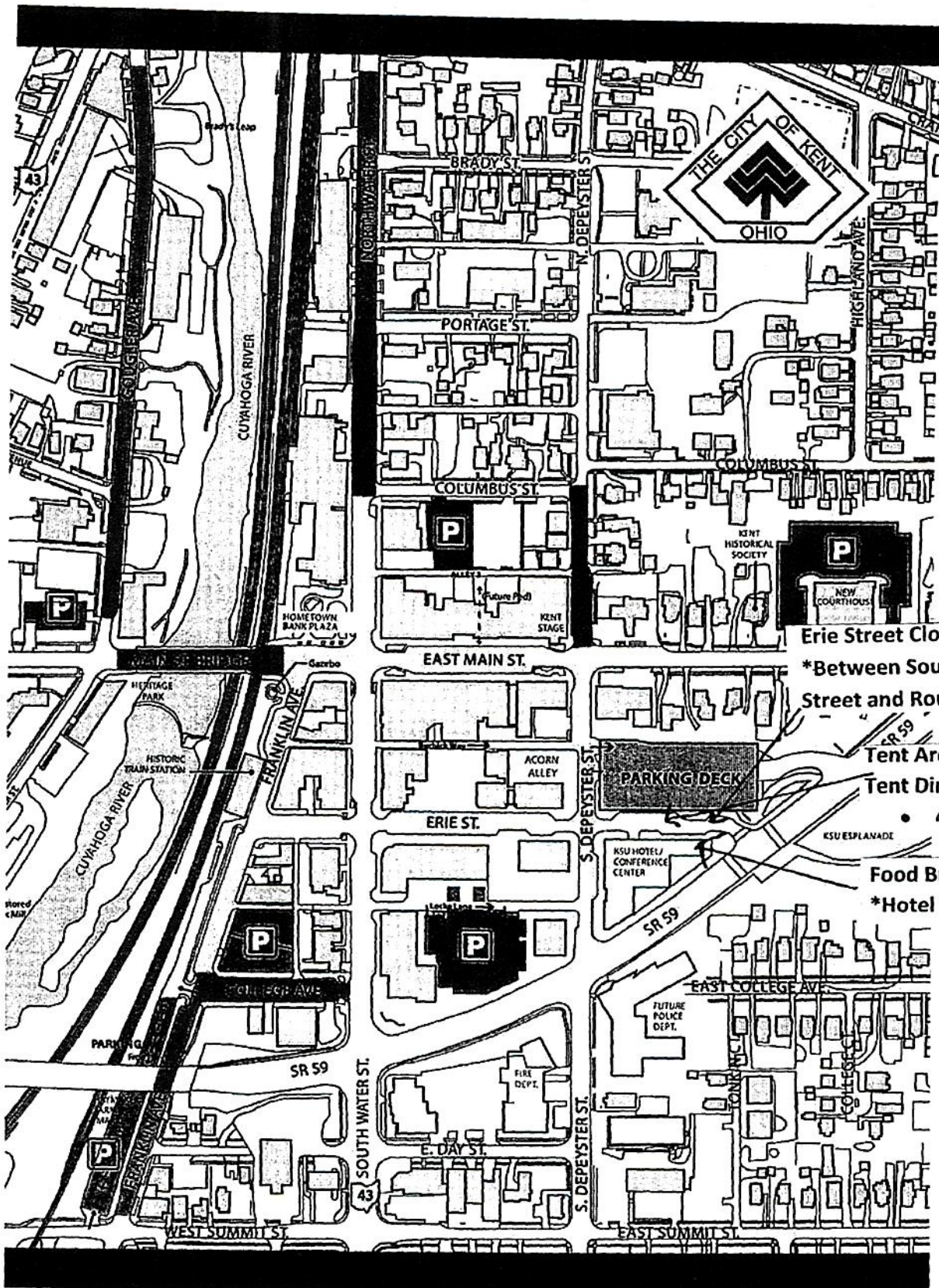
