ORDINANCE NO. 2024 - 053

AN ORDINANCE AUTHORIZING THE CITY OF KENT HEALTH DEPARTMENT TO APPLY FOR GRANT FUNDS IN THE AMOUNT OF \$199,237.00, AND TO ACCEPT THE GRANTS, IF AWARDED, WITH CORRESPONDING APPROPRIATION OF FUNDS AND DECLARING AN EMERGENCY.

WHEREAS, the City of Kent Health Department would like to apply for the following grants and if awarded they would be worth a total of \$199,237:

Creating Healthy Communities (CHC) - \$100,000; Emergency Operations (EO23) - \$74,237; and Environmental Protection Agency (EPA) - \$25,000.

WHEREAS, the City wishes to apply and accept said grants.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Kent, Portage County, Ohio:

<u>SECTION 1.</u> That Kent City Council approves submission of the application for the grant funds, execution of the subsequent agreements, and authorized that the Administration provide all information, funds, and documentation required in said applications for submission.

SECTION 2. That Kent City Council hereby approves the City's acceptance of the grants, if awarded to the City, with corresponding appropriations for its use.

<u>SECTION 3.</u> That the Kent City Council hereby understands and agrees that participation in the program will require compliance with program guidelines and assurances.

<u>SECTION 4.</u> That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

SECTION 5. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the residents of this City, for which reason and other reasons manifest to this Council this ordinance is hereby declared to be an emergency measure and shall take effect and be in force immediately after passage.
