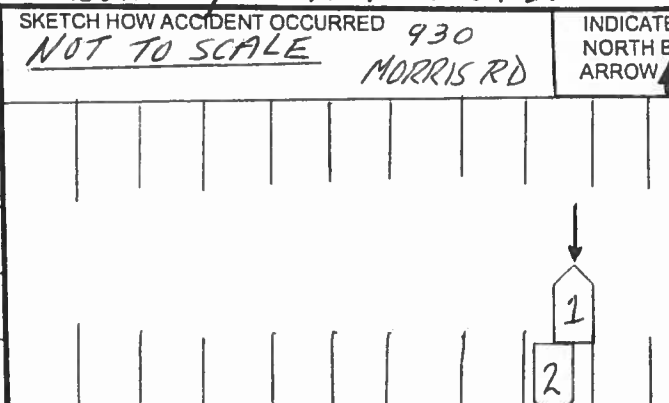

DESCRIBE HOW ACCIDENT OCCURRED

Unit 2 was unoccupied facing S/B in the parking lot of 960 Morris Rd.
