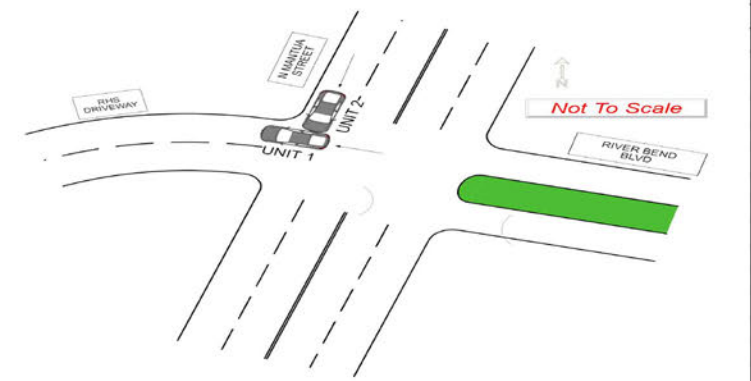
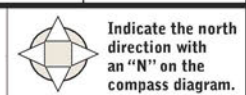

UNIT 1 WAS STOPPED AT THE STOP SIGN AT RIVERBEND BLVD, WAITING TO CROSS OVER TO ROOSEVELT HIGH SCHOOL. A DUMP TRUCK STOPPED IN THE LEFT, SOUTHBOUND LANE ON MANTUA STREET AND MOTIONED FOR UNIT 1 TO CROSS. AS UNIT 1 CROSSED MANTUA STREET, UNIT 2 WAS TRAVELING IN THE RIGHT, SOUTHBOUND LANE. UNIT 2 STRUCK UNIT 1 IN THE REAR PASSENGER SIDE DOOR, CAUSING IT TO SPIN AND END UP IN THE GRASS IN FRONT OF ROOSEVELT HIGH

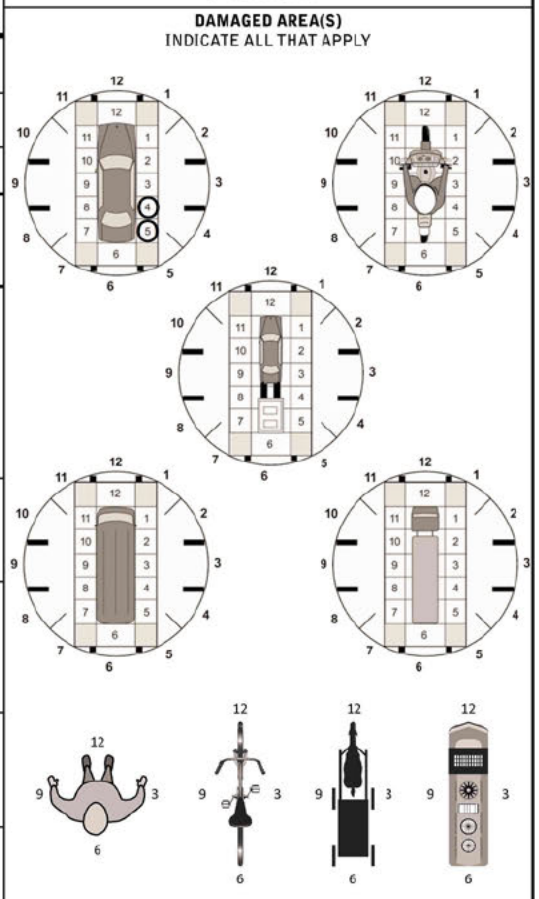
