1. Approve Water Tap-In Request for Franklin Township Resident (Draft #2018-149)

Jim Bowling is requesting Council's approval to allow the Franklin Township resident at 5819 Rhodes Road to tap into the City's water main for City water service. The City's water main is adjacent to the property and Council has approved water tap-in by Township residents on a case by case basis. This new water customer would pay a 50% rate surcharge as a non-City non-JEDD water customer. (attachment)

Chief Lee has requested Council's authorization to accept an Ohio Law Enforcement Body Armor grant in the amount up to 75% of the purchase price for protective vests for two Kent Police Officers. The grant amount is valued at \$1,162.50 (75% of \$1,574.50 purchase price). (attachment)

4. Approve the Renewal of the City Revolving Loan Fund Administration Agreement (Draft #2018-135)

Bridget has requested Council's authorization to renew the City's Agreement with the Ohio Development Services Agency for the continued administration of the City's revolving loan fund. The agreement outlines the requirements for the administration of the revolving loan funds for the period of January 1, 2019 through December 31, 2021. (attachment)

1. Health Department Statistics

Jeff Neistadt has provided a copy of the statistical report for November 2018. Health Department revenues are up 2% (\$12,604.50) and permits are down 4% (20 permits) in 2018 from 2017. (attachment)

2. Monthly Permit and Zoning Reports

Bridget Susel has enclosed copies of the monthly zoning and permit violations report for September 2018. Permit revenues were \$42,039.88 for September with the most permits being issued for HVAC Residential (28 permits). There were 13 code enforcement items in September. (attachment)
