

ORDINANCE 2023 - 005

AN ORDINANCE AMENDING ORDINANCE 2014-115, PASSED OCTOBER 15, 2014, TO AMEND THE SPECIFIED QUALIFICATIONS OF CANDIDATES FOR THE POSITIONS ON THE LOAN REVIEW BOARD; AND DECLARING AN EMERGENCY.

WHEREAS, the City of Kent wishes to amend Ordinance 2014-115, passed October 15, 2014, so as to amend the specified qualifications of candidates for the positions on the Loan Review Board; and

WHEREAS, the amendment will change the qualifications of the five (5) members to allow them to be either loan officers from different local banks, local realtors with knowledge of the commercial real estate market or local attorneys.


NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Kent, Portage County, Ohio:

SECTION 1. That Council does hereby approve an amendment to Ordinance 2014-115, passed October 15, 2014, so as to amend the qualifications to the Loan Review Board to allow for five (5) members who shall be either experienced loan officers from different local banks, local realtors with knowledge of the commercial real estate market or local attorneys.

SECTION 2. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.


