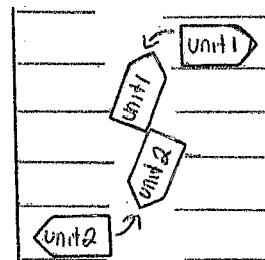
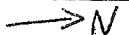
DESCRIBE HOW ACCIDENT OCCURRED
