## Information Items

### 1. Kent Police Statistics

Chief Shearer has provided a copy of the police statistics report for June 2024. In 2024, MTD calls for service are down 8.3% (by 142 calls); traffic citations are down 3.2% (by 4 tickets); accident incidents are up by 3.1% (by 102 incidents) for the month and serious crimes are unchanged, at 4 incidents when compared to June of 2023. ### 2. Income Tax Report

Rhonda Hall has provided a summary of income tax collections for June of 2024. Overall, the City income tax collections YTD are up 1.8% (\$167,229) compared with YTD of 2023. For the month of June, the City income tax collections are down 12.5% (\$207,623) compared to 2023. (attachment)
