





Public Hearing

1. New Local Historic Designation

Bridget Susel has asked the City Clerk to schedule a public hearing to receive public input on the proposal to designate the Kent Stage property (located at Main Street and Depeyster Street) as a "local historically significant" property at the property owner's request.



The City Clerk has scheduled time for Council to interview candidates for vacancies on City Boards and Commissions.

1. Dangerous Dogs Ordinance Amendment

2. Downtown Kent Local Historic Designation Request

Bridget Susel has requested Committee time to present her recommendation for Council to approve a request from the owner of the Kent Stage property to receive the City's designation as a "local historically significant" property. As a state approved "certified local government" City Council can designate appropriate properties as historically significant. With that designation in place, the owners of the property may be eligible for various funding sources to improve and restore the property. The owner of the Kent Stage has indicated that they are preparing to make financial investments in upgrading and restoring the Kent Stage.

Administration Recommendation

I recommend Council's support to designate the Kent Stage as historically significant.

Council Actions

Authorize the designation of the Kent Stage as an historically significant property.

3. City Police Building LEEDs Certification

At the July Committee meeting Council discussed the role of the LEEDs certificate in the design and construction of the new Police Facility. 8. 2014 Appropriations Amendments

<u>Information Items</u>

1. Income Tax Report

Dave Coffee has provided a summary of income tax collections thru the end of June 2014. Overall the City income tax collections are up 5.34% (\$332,223) from June 2013. Kent State University's collections thru the end of June are up 3.77% (\$87,070). (attachment)

2. Monthly Permit and Zoning Reports

Bridget Susel has enclosed copies of the monthly zoning and permit violations report for June 2014. Permit revenues were \$22,022 for the month with the most permits being issued for existing residential repairs or additions (23 permits). There were 63 code enforcement items in June, most of which were related to overgrown vegetation notices. (attachment)

3. Fire Incident Report

Chief Tosko has provided a copy of the fire and emergency medical services report for June 2014. In 2014 calls for fire service are down 1% (5 calls); fire mutual aid assistance is down 3 events in 2014; and EMS responses are down 4% (63 calls). (attachment)
