6. Wells Sherman House Loan Review

Council referred into Committee a proposal to forgive the outstanding loan balance of \$11,375 on the Well Sherman House. The original 10 year loan amount was \$15,000 at 0% interest with payment of \$125 due the first of each month. To date, \$3,625 has been paid back. Out of 27 payments made to date, 10 have been received after the due date resulting in the assessment of late fees totaling \$37.50. (attachment)
