# Information Items

### 1. Monthly Permit and Zoning Reports

Bridget Susel has enclosed copies of the monthly zoning and permit violations report for January 2012. The total number of permits issued thru the end of January were up 9% (4 permits) from last year and the corresponding revenues were up 144% (\$10,364). Troy had 29 action items in January, including following up on nuisance materials/debris, snow shoveling and illegal rooming houses. (attachment)

#### 2. Franklin Township Fire Service Rate Notice for 2012

Bill Lillich has provided a copy of the notice sent to the Franklin Township that outlines the fire service rate changes from 2011 to 2012. The rate is set based on a previously approved formula that includes a cap of \$35 for an increase in any given year. The cost per incident increased from \$1,121 to \$1,156. (attachment)

#### 3. Fire Incident Report

Jim Williams has provided a copy of the fire and emergency medical services report for January 2012. In January 2012 calls for fire service are up 42% (26 calls); fire mutual aid assistance is up by 7 events in 2012; and EMS responses are up 21% (49 calls). (attachment)

#### 4. Downtown Parking Update

I wanted to let you know that the change in the parking signage on Erie Street (from permit parking to 2 hour) went into effect on Monday and the change has definitely helped relieve some of the parking problems around the new businesses in Ron Burbick's latest redevelopment phase.

# 5. City/County Land Swap Agreement

Jim Silver has been working with the County's attorney this week to wrap up the details on the terms of the land swap agreement with the County. It appears that we have resolved all of the issues to our mutual satisfaction so now we can focus on the land acquisition with the current property owner and proceed to complete the transaction. We plan to discuss the land acquisition with Council in executive session in March.

Please find attached check number 1366 in the amount of \$1,000.00 from the Christenson Foundation intended for the City's Beautification Program.

Historically, the City has received a grant from the Christenson Foundation each year since 2007 for the Adopt-a-Spot program with the exception of last year (2011). The last donation from the Christenson Foundation was received by the City in 2010. The 2010 donation was forwarded onto Main Street Kent as part of the 2010 agreement with Main Street Kent to administer the Adopt-a-Spot Program. No donation was received by the City in 2011 from The Christenson Foundation. I spoke to Mr. James Krauss of the Christenson Foundation on January 26, 2012 regarding this matter and he would prefer that we not return the check.

The agreement for the administration of the 2012 Adopt-a-Spot program has not been finalized. I am requesting that the donation from the Christenson Foundation be accepted by Kent City Council at this time, with the understanding that the funds will be forwarded to Main Street Kent or other non profit organization that the City enters into an agreement with for administration of the Adopt-a-Spot Program.

Dear Trustees Beckwith, Benjamin and Falstad,

This letter and attached calculations will represent the City's notice regarding the fire service rates for Franklin Township for 2012. This rate analysis is based on the basic method that has been used for years. It is further modified by the adjustment to the rate cap per run from \$25 to \$35.

#### Rate calculation

The preliminary calculation of rates for the year 2012, as determined by the basic contract process, are based on the following data:

A. The city's cost of operation of the Kent Fire Department for 2012 is budgeted as follows:

The cost per incident estimate for the Kent Fire Department, based on the above data, calculates to \$1,169.93 per incident. This compares to the cost per incident of \$1,121.50 that was charged to the Township during 2011. Due to the \$35 cap on the increase in the current agreement, your new rate will be \$1,156.50 per incident response.
