ORDINANCE NO. 2019-98

AN ORDINANCE ACCEPTING A DONATION OF TWO (2) HARD PLASTIC PET CARRIERS DONATED BY DARLENE ARDELIAN, VALUED AT \$40.00 EACH, AND DECLARING AN EMERGENCY

WHEREAS, the City of Kent Police Department has worked with Ms. Darlene Ardelian in the past concerning feral cats in the Walter Street area; and

WHEREAS, Ms. Darlene Ardelian purchased the pet carriers for the Animal Compliance Officers to assist them in dealing with feral cats or stray animals; and

WHEREAS, the City wishes to accept said donation.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Kent, Portage County, Ohio, at least three-fourths (3/4) of all members elected thereto concurring:

SECTION 1. That Council does hereby authorize the City Manager, or his designee, on behalf of the City of Kent Police Department to accept two (2) hard plastic pet carriers valued at \$40.00 each.

SECTION 2. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the residents of this City, for which reason and other reasons manifest to this Council this Ordinance is hereby declared to be an emergency measure and shall take effect and be in force immediately after passage.
