Commissioner's Report

Enclosed is the Proposed 2009 Health Department Operating Budget. The budget is broken into five funds: General, Sewer, Revolving Housing, Food Service, & Swimming Pools. Please review for discussion and approval under New Business.

Enclosed is Annual Kent Health Department Newsletter for review.

Since May 1, 2007, there have been 27 complaints of the Smoke-Free Workplace Law. The Kent Health Department has investigated or is in the process of investigating all of them. 26 of the complaints were anonymously filed & one signed. 24 complaints were dismissed insufficient evidence. Two cases a letter of warning will be issued, one is still under investigation.

Enclosed is a written request to transfer food license FSO 08-129 of the Wild Goats Café from the previous owner J&J Grimm, Inc. to a new owner, CEC Foods, LLC. Charles Ciborek. The Food Service Operation is in good standing and the Health Commissioner recommends the transfer.

John Gwinn and I meet with Kent City School Superintendent Joe Giancola and school administrators on May 19, 2008 to discuss a draft Pandemic Flu Plan for Kent City School District.

Old Business

Annual Health Department Newsletter, comments on the revision include: Insert the year 2008 on front page of the Newsletter; relocate address information of the Health Department from back page to the front; the Five Year Expenditure Trend Graph should either be removed, or explained somehow what you expect the reader to learn from the graph; the useful telephone numbers on page 3 should list the Kent City Health Dept. and Portage Co. 211; the program summary on Mosquito Control, 2nd paragraph should begin with a capital; last sentence should be rewritten as: Testing on one bird for West Nile Virus was found to be negative.

Chris Woolverton asked about the trash hauling issue in Kent. John Ferlito stated that it would be on Council Agenda for July.

New Business

2009 Proposed Budget Review: reviews of each fund and account lines of proposed expenditures for next year took place. John Gwinn noticed that John Bradshaw is requesting a replacement van for the lab, and Mr. Gwinn asked that he look into a type of hybrid vehicle to see if it would be feasible or more cost effective. Tom Bialke asked John Ferlito if there is enough money budgeted for Housing Demolitions and if there is any pay back of the costs incurred by the Health Dept.. John explained that there is a lien placed on the property for the cost of razing, if the lot would be sold, we could recoup if not all, part of the costs during the sale. John Gwinn asked, besides the State mandated programs, where are the other programs funded from? John Ferlito stated that they are funded through the General Fund (ie., mosquito control, rabies, nuisance complaints, etc.). John Gwinn asked if subcategories could be added so that we are aware where money is being spent. John Ferlito stated that he does not see Finance adding more lines to the City budget. The information the Board wants, will need to be tracked by Health Dept, staff.

Black squirrel to fly at Kent fireworks

Iconic creature's image to be projected on silo and smoke at festival

Black squirrels are on his mind

So it doesn't seem that strange that the 50-year-old owner of MP Productions plans to flash the image of the critter 150 feet off the ground during the fireworks display Saturday evening at the Kent Heritage Festival. The image will be on the top of the Star of the West Milling Co. silo on North Water Street.

If the weather conditions are right, Pritt plans to use a second light downtown to project the image on leftover smoke from the fireworks.

"If it's not too windy and if the smoke hangs," he said, "I will do the symbol on the fireworks."

Pritt said people will relate to image because everybody has a story to tell about the Kent black squirrel.

"They are everywhere," he said.

According to the registrar's office at Kent State University, black squirrels arrived in the city from Canada in 1961, when 10 of the animals were introduced to the campus by Larry Woodell, superintendent of grounds, and M.W. Staples, a retired executive of the Davey Tree Expert Co.

The squirrel has become so associated with the university that the on-campus station is known as Black Squirrel Radio.

Dan McMillen, private lands biologist for the Portage Lakes office of the Ohio Division of Wildlife, said black squirrels now can be found all over Northeast Ohio and in other parts of the state.

"It is a recessive gene that pops up irregularly," McMillen said. "I live in rural Harrison County and I've seem them."

Pritt got his image of the squirrel from McKay Bricker Gallery & Framing in Kent.

Cass McKay Mayfield, who owns the business with her husband, Bob, said Kent artist Larry McFarland designed the image.

"We asked Larry to create a profile of a running squirrel," she said, "and the three of us, sitting in front of his computer, tweaked it."

The image has been used on items sold in their store,

including T-shirts, caps and bumper stickers, for the past four years, Mayfield said. It's also found on the fence at the gallery on North Mantua Street.

Pritt then contacted another company by mail and had it use the squirrel image to create a gobo, a piece of metal that is placed in front of a light source so that the shape can be displayed on a surface.

He was so excited when he received his black squirrel gobo, that he took some of his lighting equipment and went to downtown Kent to see what it would look like if he projected the image on the side of a few buildings at night.

People saw the image and got excited about it, said Pritt, a Tallmadge High School graduate.

After that, he came up with the idea of shining the squirrel image during the Jeff Graham Memorial Fireworks display at the Kent Heritage Festival.

Pritt made a test run last weekend, shining the squirrel image on the Kent water tower.

Steve "Red" Michel, plant manager of West Star Milling Co., said he hopes the squirrel image on his silo Saturday will "shine a little light on downtown."
