1. Board of Health Appointment (draft # 09-87)

The Board of Health has a vacancy and there is a recommendation to appoint Mr. Doug Wagener for an unexpired term ending 4/30/12.

Information Items

1. Bicentennial Fund Balance

As Council's representative to the Kent Bicentennial Committee, Mayor Fender invited Pat Morton to meet with me to discuss the status of the Kent Bicentennial projects. You may recall that the previous City Council had allocated \$24,000 of City funds to support the Bicentennial events scheduled over the course of Kent's Bicentennial year. As those events occurred the City reimbursed the Bicentennial Committee for appropriate expenses. At the end of the Bicentennial year the City had a balance remaining in the Bicentennial fund of approximately \$11,000.

In addition to the year long events, the Bicentennial Committee was also working with a local artist to pay for a ceremonial art sculpture commemorating Kent's 200th year. Pat Morton and the Mayor advised me that the Bicentennial Committee is still working on fund raising to complete the ceremonial art sculpture, and the Mayor discussed the possibility of seeking Council's approval to dedicate the remaining City Bicentennial funds to contribute to the art sculpture costs since we are not expecting any further event reimbursement requests. I offered to share this request with you in this communication in the event that one of you may want to make an appropriate motion to this effect during the meeting next week.
