Information Items

1. Income Tax Report

Rhonda Hall has provided a summary of income tax collections for April of 2023. Overall, the City income tax collections YTD are up 12.3% (\$643,715) compared with YTD of 2022. For the month of April, the City income tax collections are up 2.1% (\$29.384) compared to 2022. (attachment)

2. Kent Police Statistics

Chief Shearer has provided a copy of the police statistics report for April 2023. In 2023, calls for service are down 7% for the month (by 119 calls); traffic citations are down 33.7% (119 tickets); accident incidents are down 20% at 39 incidents for the month and serious crimes are unchanged (2 incidents) compared to April of 2022.
