

Unauthorized Items

1. Authorize ROW Acquisition for Hike & Bike Trail Extension (Draft #17-03, 17-06)

Jim Bowling has requested Council's authorization to purchase a permanent easement and temporary right of way for the Portage Hike and Bike Trail SR59 segment that is planned to begin construction in 2017. This approved capital project will provide an off-street connection from the end of the Esplanade down to Franklin Avenue along SR59. From Franklin, the Hike and Bike Trail will use an on-street connection leading to the trailhead at Tannery Park on Stow Street. To complete this planned connection, the City has reached terms with Walgreens and the Walgreens property land owner to secure the right of way necessary to build the trail along the edge of their property on SR59. Administration Recommendation

Walgreens has agreed to donate their portion of the necessary right of way (valued at \$4,450) and the underlying land owner has agreed to the fair market value price of \$20,000 for the remaining portion of land required for the project. The project is approved in the City Capital Plan and is funded by Kent Parks and Recreation and a \$700,000 AMATS grant. ODOT has requested the City's authorization by the end of this month and I recommend Council's support.

Council Actions

Authorize the right of way donation and acquisition for the Hike and Bike Trail extension on SR59.



2. Accept a Donation for Parks and Recreation (Draft No. 17-04)

John Idone is requesting Council's authorization to accept a donation from the Henry V. and Frances W. Christenson Foundation in the amount of \$1,500 for beautification of Kent parks. (attachment)

Information Items

1. Health Department Statistics

Jeff Neistadt has provided a copy of the statistical report for December 2016. Health Department revenues are up 9% (\$45,927) and permits are up 8% (42 permits) in 2016 from 2015. (attachment)

5. Monthly Permit and Zoning Reports
