# Land Use Committee





Jim is requesting Committee time for Council's consideration of a proposed Agreement between the City and Klaben that would allow for the construction of a new, wider sidewalk along the City right of way and Klaben property frontage on West Main Street. (attachment)

Administration Recommendation

The proposed wider sidewalk would be safer, more functional, and provide a connection for the Portage Hike & Bike trail. I recommend Council's support for the Agreement.

Council Action

Authorize the proposed Agreement between the City and Klaben for a new section of the Hike & Bike trail as presented.

# Streets, Sidewalks & Utilities Committee

1. Proposed Erie Street Closure for Possible Community Ice Rink (Jim)



Jim has requested Committee time for Council's consideration of a request to close a section of Erie Street (between the PARTA garage and KSU Hotel) for the possible construction of a temporary seasonal ice rink (late December – February) that would be available for KSU students and Kent community members. (attachment)

#### Administration Recommendation

The City and KSU staff have been discussing the idea of a community based ice rink as a way to provide safe, outdoor activities during the winter months. The eastern section of Erie Street has low usage during the winter months so staff is recommending Council's support for the possible street closure for the rink as a way to assist downtown businesses. It is unclear whether the ice rink will be possible depending upon the severity of the pandemic but we would like Council's authorization in case it turns out to be possible.

#### Council Action

Authorize the proposed closure of this section Erie Street for the winter months as presented.

## Finance Committee



Hope is requesting Council's authorization to renew the City's contract with the Portage County Office of the Public Defender for the purposes of legal counsel to indigent persons for the period of January 1, 2021 through December 31, 2021. (attachment)

Administration Recommendation

This is an annual contract renewal that Hope and I recommend for Council's authorization.

Council Action

Authorize the renewal of the Portage County Public Defender's contract for 2021.

### 2. Presentation of the Proposed 2021 City Operating Budget (Rhonda)

#### 4. "Then and Now" Purchase Order List for Certification (Rhonda)

Rhonda has requested Committee time for Council's certification of the list of "then and now" purchase orders made in 2020 that exceed \$3,000. The list of "Then and Now" purchase orders has been verified by Rhonda that at the time the order was made ("then"), and at the time of final authorization ("now"), sufficient funds were available and properly budgeted for the purchase. Administration Recommendation

Ohio Revised Code requires Council's certification of the "then and now" list, and I recommend Council's support.

Council Actions

Authorize the "then and now" list of purchase orders for 2020 as presented.

#### 5. Accept a Phone Charging Station from NOPEC (Melanie)


