### 1. Boards and Commissions

### 3. Traffic Engineering Recommendations

Staff has recommended a stop sign at Naturewood Circle @ Stonewater Drive, and No Parking on the south side of Naturewood Circe.

Council authorization of the installation of a new stop sign and no parking restrictions on Naturewood Circle.






# Information Items

### 1. Income Tax Receipts

Barb has provided the 6 month income tax report for January 1 thru June 30, 2007. The gross income tax revenues for 2007 are up compared to the last 2 years, which is good news, but the bad news is that the income tax growth has not kept pace with an average 3% growth in inflationary costs for the City (see chart below).
