ORDINANCE NO. 2021 - 094

AN ORDINANCE SETTING THE RATE OF PAY FOR THE MAYOR OF KENT, OHIO AND DECLARING AN EMERGENCY.

WHEREAS, a Citizen panel was appointed in 2021 to review the rates of pay for the Mayor and City Council members for the City of Kent and to make recommendations for any changes they felt were needed; and

WHEREAS, the Citizen panel recommended increasing the rates of pay for both the Mayor and City Council members; and

WHEREAS, the Citizen panel recommended an increase in the rate of pay for the Mayor of Kent to \$11,500.00 per year beginning January 1, 2022 with a 1.75% increase beginning 2025 and each year thereafter through 2029.

WHEREAS, the Mayor has no vote on this issue.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Kent, Portage County, Ohio, that:

SECTION 1. The rate of pay for the position of Mayor for the City of Kent, Ohio be increased to \$11,500.00 per year beginning January 1, 2022 with a 1.75% increase beginning 2025 and each year thereafter through 2029.

SECTION 2. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the residents of this City, for which reason and other reasons manifest to this Council, this Ordinance is hereby declared to be an emergency measure and shall take effect and be in force immediately after passage.
