ORDINANCE NO. 2021-048

AN ORDINANCE AUTHORIZING THE TRADE IN / AUCTION/ DISPOSAL OF VEHICLES, LARGE EQUIPMENT AND TRAILERS NOT NEEDED FOR MUNICIPAL PURPOSES, AND DECLARING AN EMERGENCY.

WHEREAS, the City has vehicles and large equipment that will be replaced as per the approved Capital Plan already approved; and

WHEREAS, some of the vehicles and equipment are being traded in to help offset the cost of new vehicles and equipment; and

WHEREAS, two (2) vehicles are going to auction.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Kent, Portage County, Ohio, that:

SECTION 1. Council does hereby authorize the City to trade in / auction/ dispose of vehicles, large equipment and trailers no longer needed for municipal purposes and are described on the attached list, marked "Exhibit A" and incorporated herein.

SECTION 2. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the residents of this City, for which reason and other reasons manifest to this Council this Ordinance is hereby declared to be an emergency measure and shall take effect and be in force immediately after passage.
