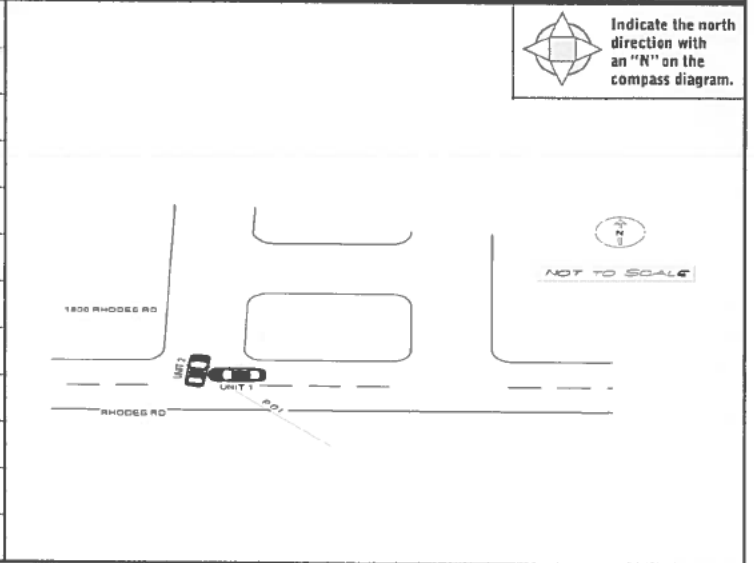

NARRATIVE

Unit 1 was traveling from east to west on Rhodes Road. Unit 2 was traveling from west to east on Rhodes Rd. While turning north into 1800 Rhodes Rd, Unit 2 turned directly into the path of Unit 1 (still traveling westbound); causing Unit 1 to strike the passenger side of Unit 2.

Unit 1 then flagged down KSU Officer Spahr #326 after Unit 2 failed to stop after the accident.

The driver of Unit 1 stated she was uninjured and

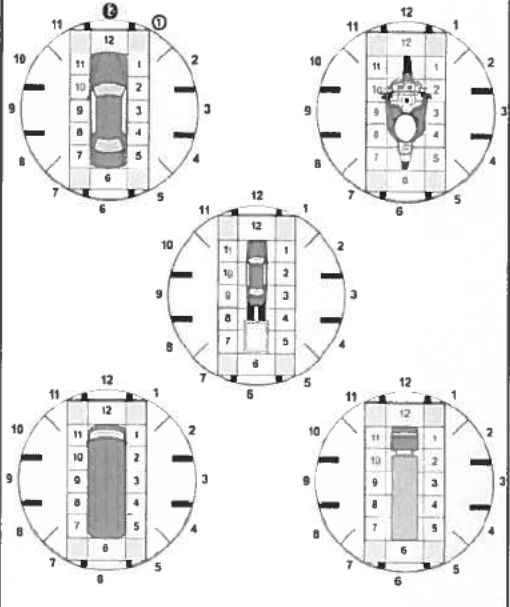

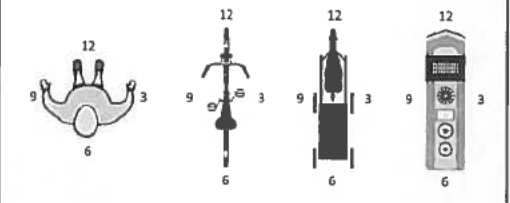
