AN ORDINANCE AUTHORIZING THE CITY MANAGER, OR HIS DESIGNEE, TO ACCEPT A GRANT FROM THE OHIO EPA IN THE AMOUNT OF \$25,000.00 TO BE USED TO FUND THE MOSQUITO CONTROL PROGRAM THROUGH APRIL 2023, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Kent's Health Department has been awarded \$25,000.00 from the Ohio EPA Grant Award program; and

WHEREAS, the awarded \$25,000.00 will be used to fund the mosquito control program through April 2023 and will be available in May 2022; and

WHEREAS, the City wishes to accept said grant.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Kent, Portage County, Ohio, that:

SECTION 1. Council does hereby authorize the City Manager on behalf of the City of Kent's Health Department to accept the Ohio EPA grant award in the amount of \$25,000.00 for the mosquito control program, and for the Budget and Finance Director to appropriate the award into the proper fund.

<u>SECTION 2</u>. it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

<u>SECTION 3</u>. this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the residents of this City, for which reason and other reasons manifest to this Council this Ordinance is hereby declared to be an emergency measure and shall take effect and be in force immediately after passage.
