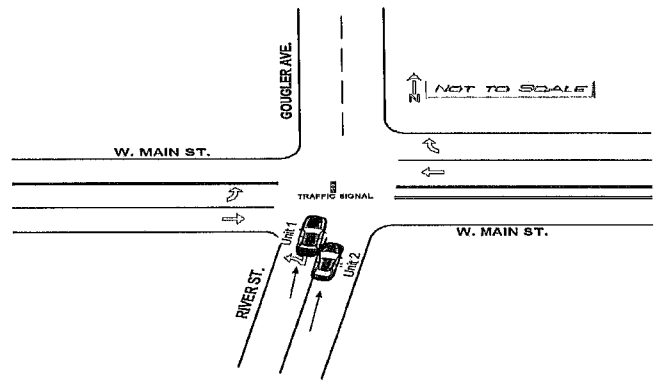

THE DRIVER OF UNIT 1 ADVISED THAT SHE WAS NB ON RIVER ST. CONTINUING THROUGH THE INTERSECTION AT THE GREEN LIGHT AND UNIT 2 ATTEMPTED TO TURN WB ONTO W. MAIN ST. FROM THE RIGHT LANE STRIKING HER VEHICLE. THE DRIVER OF UNIT 2
