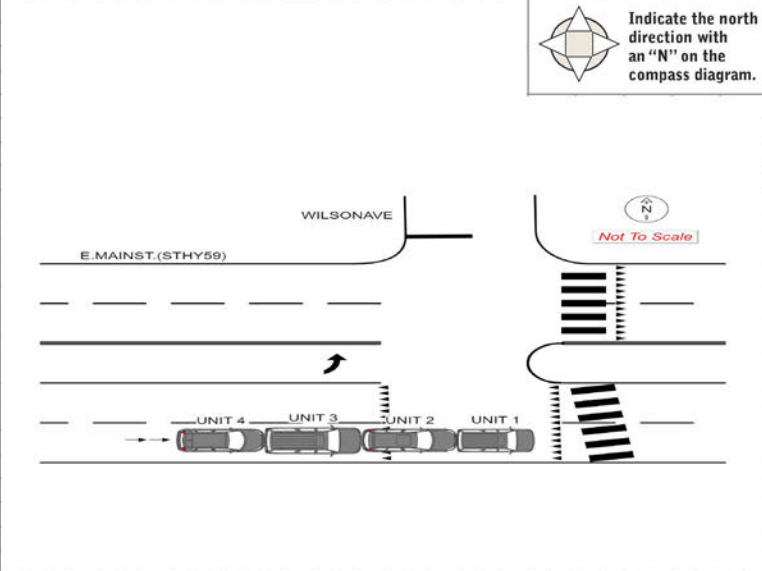
NARRATIVE

Unit Three was traveling Eastbound on E. Main St. in the right hand lane, stopped behind Unit Two.

Unit Four was traveling Eastbound on E. Main St. in the right hand lane behind Unit Three. Unit Four failed to maintain assured clear distance ahead striking the rear of Unit Three. The force of the

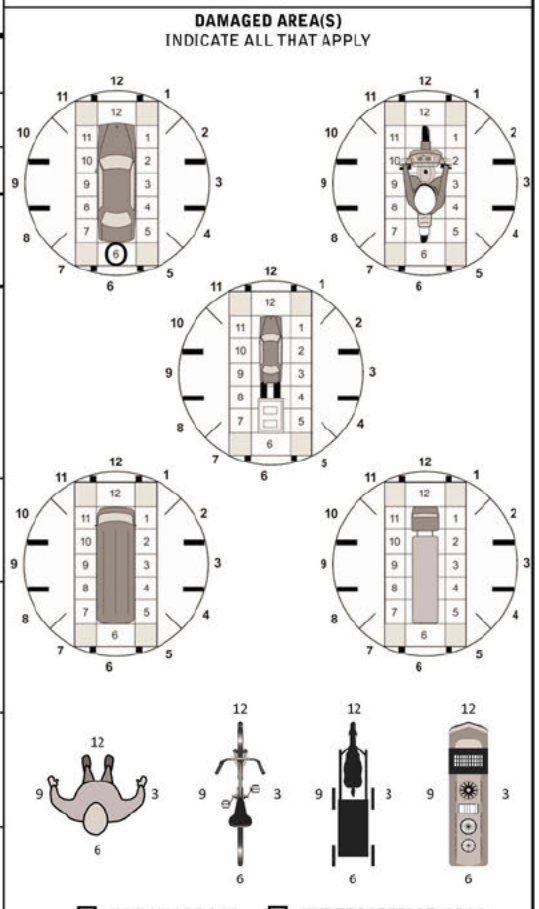
