

Special Council Meeting Items

The Clerk has posted a special Council meeting for Monday night at 5 pm to discuss contract negotiations and a couple of land acquisition items. The staff and I will join you in executive session for review of these items.

Information Items

1. NOPEC Notification of FirstEnergy Electric Rate Increases for 2009 I have attached a memo from Leigh Herington, Executive Director of NOPEC, advising of FirstEnergy's refusal to extend the electric rate discount currently offered to NOPEC communities and to raise the rates under a recently approved rate plan. NOPEC is recommending contacting our state representatives and urging state intervention on our resident's behalf. (attachments)

2. Traffic Engineering and Safety Meeting Summary

Bill Lillich has provided a summary of the discussion from the October 17, 2008 Traffic Engineering and Safety meeting. The items reviewed include: SR261 signal changes at Mogadore and Sunnybrook Road, SR59 signal project update, E. main Street pedestrian island, N. Mantua Street school zone markings, Crain Avenue traffic calming, E. Summit Street signage, E. Main Street sidewalk ramps, no turn on red at Summit & Morris, audible pedestrian signals, and College Ct. parking regulations. (attachment)

7. Kent Ravenna Bike Trail Connection

The high school sports rivalry between Kent and Ravenna remains strong but I'm pleased to announce that when it comes to bike trails we set rivalries aside. The Portage Park District and Kent Parks and Recreation will be celebrating the grand opening of the final phase of the bike trail linking Kent and Ravenna. The dedication takes place at 10 a.m. on November 1st at the Lake Rockwell trailhead, just south of Beckwith's Orchards, 1617 Lake Rockwell Road in Franklin Twp.

8. Sports Tourism in Action: Kent High School Lacrosse Tournament

The City Manager's Office continues to work with Kent State Athletics, Kent State School of Sports & Leisure and Kent Parks and Recreation to attract move sporting events to venues in Kent. Last year our interns landed the Ohio high school rugby state tournament and this year they've organized a new Fall high school lacrosse tournament that is scheduled for November 1, 2008. The tournament is bringing 14 of the top regional teams to Kent to compete in a round-robin double elimination tournament. The championship game will be held in Dix stadium. This is planned to be an annual event that we believe can attract 50+ teams in future years.

9. Kent Franklin JEDD Revenues

The Kent Franklin JEDD Board met this month and we reviewed our JEDD receipts. As you can see in the attached spreadsheet the Kent Franklin JEDD has brought in nearly \$300,000 to the City of Kent in the first 18 months of operation.
