RE: Position Allocation Ordinance Modification for Central Maintenance Division

The following request is in keeping with the previously approved Kent City Council Motion as discussed during the Finance Committee on November 5, 2014 and approved at the Regular Council Meeting on November 19, 2014. Council approved changing the staffing within the Central Maintenance Division by decreasing Service Workers and replacing with an increased number Laborers.

Further staff changes will be requested in additional phases resulting in the total decrease in the number of Service Workers through attrition to six with the offsetting increase to eight Laborers at completion. Total increase in staffing from the start of this process will be plus two workers.

This current requested modification will require changing the current 2015 Position Allocation Ordinance (2015-53) with the following recommended language changes.
