### 1. Proposed Kent-Franklin JEDD Contract Amendment

### 2. Proposed PARTA-City Health Department Lease Agreement

The staff have requested Committee time to present a proposed new lease agreement that would allow the City Health Department to relocate into vacant office space on the 2<sup>nd</sup> floor of the PARTA Central Gateway in downtown Kent. The Health Department lease with KSU will expire next summer and PARTA has offered competitive pricing terms for guality office space and a long term lease.

### Administration Recommendation

The Health Board and Department staff have identified the space in PARTA as their preferred place to relocate and given the favorable terms of the lease, I recommend Council's support.

# Information Items

### 1. Income Tax Report

Dave Coffee has provided a summary of income tax collections thru the end of October 2019. Overall the City income tax collections are up 3.08% (\$368,594) from October 2018. Kent State University's collections thru the end of October are up 0.02% (\$723). (attachment)
