ORDINANCE NO. 2023 - 033

AN ORDINANCE AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO ACCEPT A CENTERS FOR DISEASE CONTROL AND PREVENTION (CDC) PUBLIC HEALTH THE WORKFORCE DEVELOPMENT 23 GRANT IN THE AMOUNT OF \$360,000 AND REQUESTING TO APPLY FOR AN ADDITIONAL ENHANCED OPERATIONS (EO23) GRANT IN THE AMOUNT OF \$70,832 FOR THE CITY OF KENT HEALTH DEPARTMENT, AND DECLARING AN EMERGENCY

WHEREAS, the City of Kent Health Department has been awarded a Centers for Disease Control and Prevention (CDC) Public Health the Workforce Development 23 Grant in the amount of \$360,000.00; and

WHEREAS, in addition to receiving this grant, the Health Department would like to apply for an additional \$70,832.00 Enhanced Operations (EO23) Grant; and

WHEREAS, the City wishes to accept said grant and apply for an additional grant.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Kent, Portage County:

SECTION 1. That Kent City Council hereby authorizes the City Manager, or his designee, to accept the Workforce Development 23 Grant in the amount of \$360,00 and apply for an additional \$70,832 Enhanced Operations (EO23) Grant for the City of Kent Health Department, and for the Budget and Finance Director to appropriate the award into the proper funds.

SECTION 2. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

<u>SECTION 3</u>. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of the residents of this City, for which reason and other reasons manifest to this Council this Ordinance is hereby declared to be an emergency measure and shall take effect and be in force immediately after passage.
