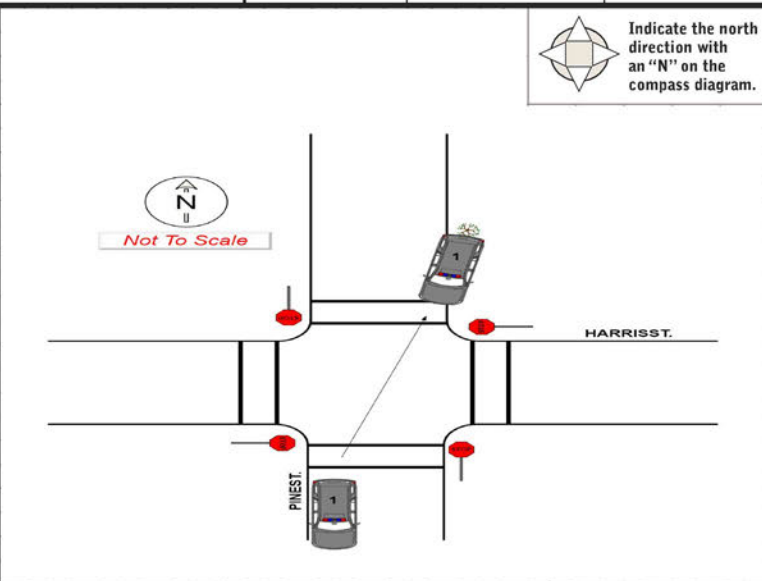

**UNIT 1 WAS A POLICE CRUISER RESPONDING TO AN EMERGENCY CALL FOR SERVICE. UNIT 1 STOPPED ON THE WEST SIDE OF PINE ST. JUST SOUTH OF THE INTERSECTION OF HARRIS ST. DRIVER OF UNIT 1 EXITED THE VEHICLE AND FAILED TO PUT THE VEHICLE IN PARK. UNIT 1 ROLLED BACKWARDS AT A SLOW SPEED, OFF THE EAST SIDE OF PINE ST., AND STRUCK A SMALL TREE WHERE IT CAME TO REST.**

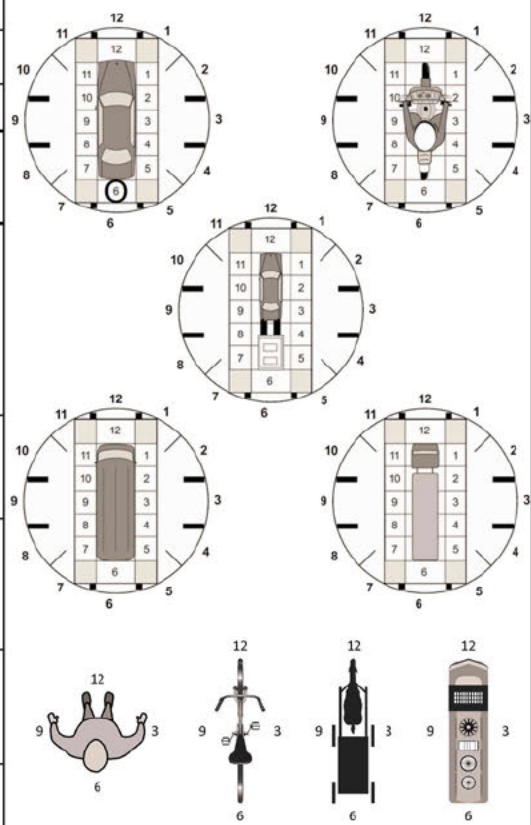
