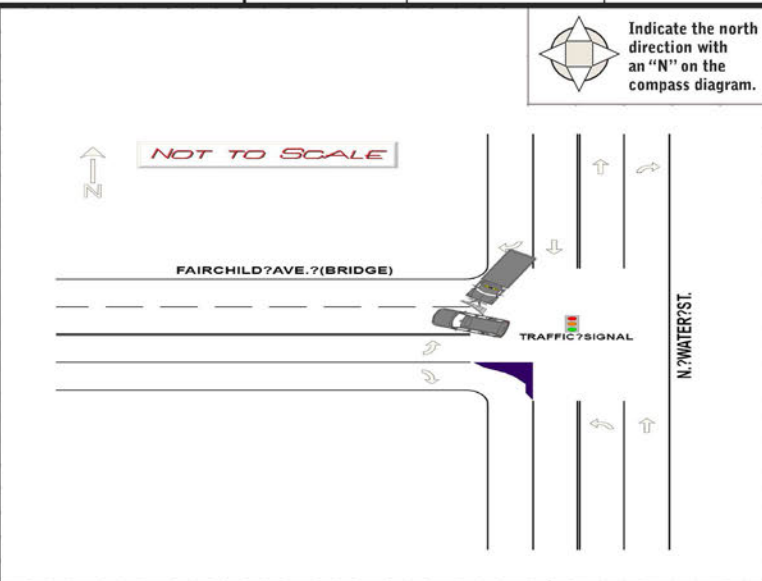

UNIT 2 FAILED TO YIELD TO UNIT 1 AND STRUCK THE SNOW PLOW ON THE FRONT OF UNIT 1. THERE WAS NO VISIBLE DAMAGE TO UNIT 1. UNIT 2 CAUSED A 2 VEHICLE PROPERTY DAMAGE ONLY CRASH.

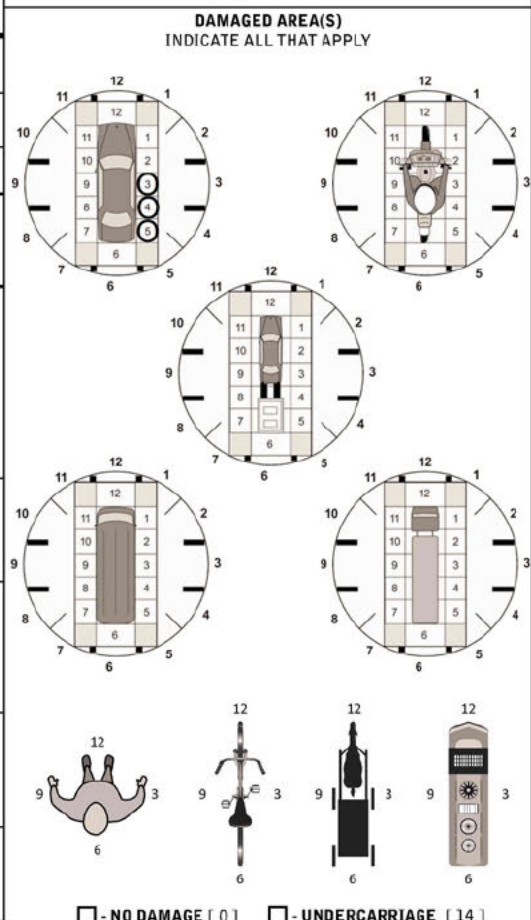
