1. Utility Discount Program Overview

Dave Coffee has requested Committee time to provide an overview of the process being employed to ensure that eligible customers receive the City utility discount. Dave reports that eligible renters will have to go through an application review process (estimated at 15 days) before the discount would go into effect but his Department is capable of providing that discount immediately. 3. Water Reclamation Lab Services Organizational Change

Gene Roberts has been working with Jeff Neistadt, Health Commissioner, to evaluate the staffing of the Water Reclamation Facility lab services and organizational assignments of those employees. Gene and Jeff have requested Committee time to present to Council their recommendation to reassign 3 employees from the Health Department to the Water Reclamation Division of the Service Department. Administrative Recommendation

The Health Board voted to approve the reassignment of the lab services employees on December 13, 2012, and I would recommend City Council's support.

4. General Compensation Plan Changes for 2012

Liz Zorc has requested Committee time to seek Council's approval to update the status of the terms of the General Compensation Plan for City employees that are not in collective bargaining units. The changes include establishing the same pay rate changes approved in the union contracts; 0% in 2012, 1% in 2013, and 2% in 2014, and increasing the health care contributions also consistent with the unions. 1. Planning Commission January 3rd Agenda and Staff Report

Bridget Susel has provided a copy of the January 3rd Planning Commission agenda and staff report. The Planning Commission will be considering one item; site plan and conditional zoning for the PARTA multi-modal facility (Kent Central Gateway and Multi-Modal Center) at 201 East Erie Street. 2. Health Board Meeting Minutes and Department Statistics

Jeff Neistadt has provided copies of the Health Board agenda (for the December 13th meeting) and the statistical report for November 2011. Health Department revenues are up 10% (\$19,680), inspections are up 1.5% and permits are down 4% in 2011 from 2010. (attachment)

Dave Coffee has provided a summary of income tax collections thru the end of November 2011. Overall the City income tax collections are up 3.4% (\$328,868) from November 2010. Kent State University's collections thru the end of November are down .24% (\$9,526). (attachment)

5. Silver Oaks Item Donations

Bridget Susel reports that the owners of Silver Oaks properties has offered to donate items that will not kept in the remodeling of the Silver Oaks property to Family and Community Services and the Habitat for Humanity Restore. At last check the items included 260 stoves/fridges, playground equipment, doors, sinks, etc. The local agencies are thrilled to take these much needed items.

6. KSU Housing Demo on Erie Street for Esplanade

Staff at Kent State report that the salvage operations in the two homes on Erie Street and the two homes on Willow Street are now complete. The demolition contractor, Lockhart, has scheduled to begin the demolition immediately following the holidays, starting on Tuesday, January 3rd. A fifth home, located on the northeast corner of Willow and College, will not begin until after the first four are demolished, and that home will also require several weeks of salvage prior to demolition. I've been told that most of the salvaged materials are being provided to Habitat for Humanity for reuse locally.
