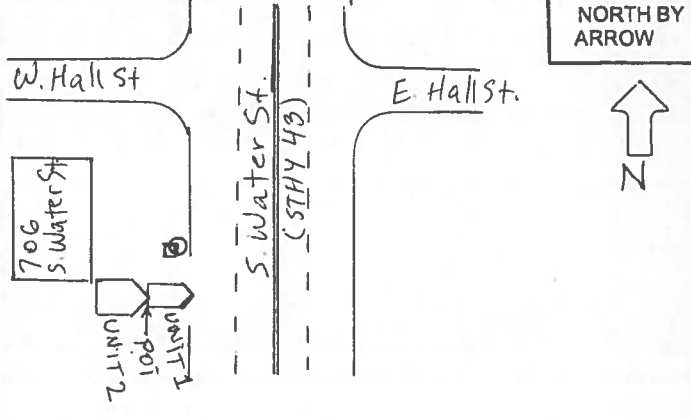




DESCRIBE HOW ACCIDENT OCCURRED

Unit 1 was pulling out of the Gulf gas station at 706 S. Water St. Unit 1 stated he stopped before entering the roadway but his view was obstructed by a telephone pole and sign. When he pulled up to see past the pole and sign, he noticed vehicles coming southbound on S. Water St. towards him. He backed up to avoid an accident on the roadway and backed into Unit 2 who was behind him in the parking lot.
