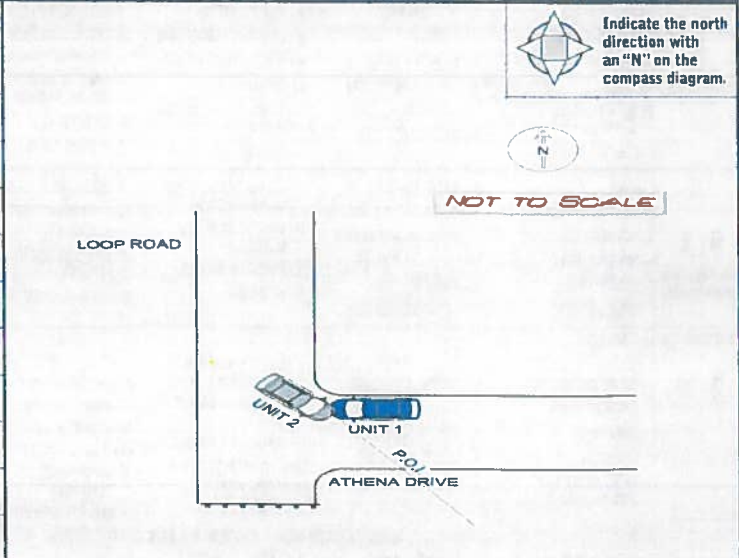
NARRATIVE

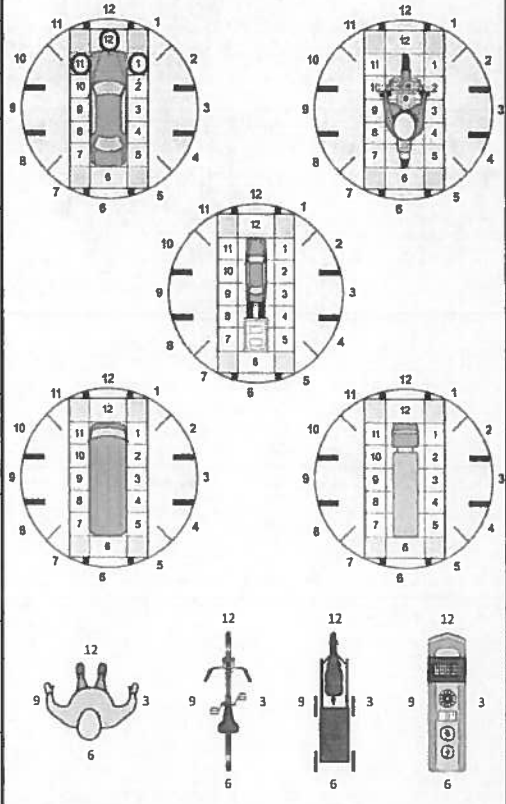
