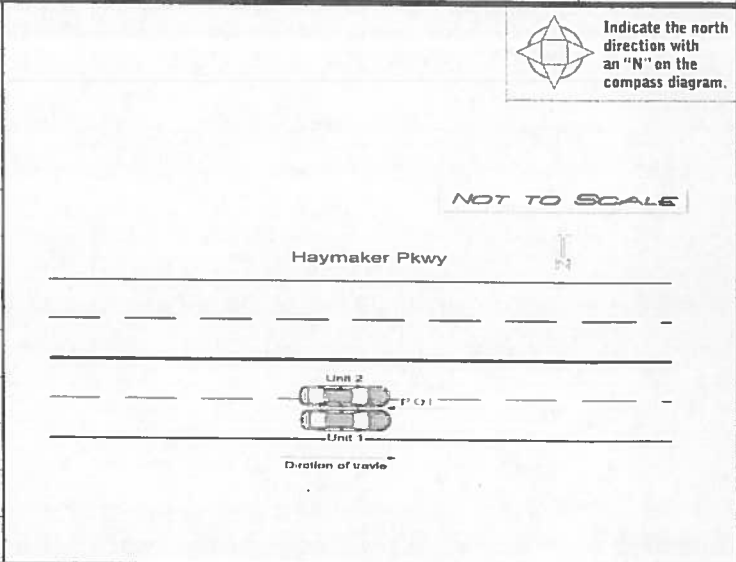

The driver of Unit 2 admitted to not having her



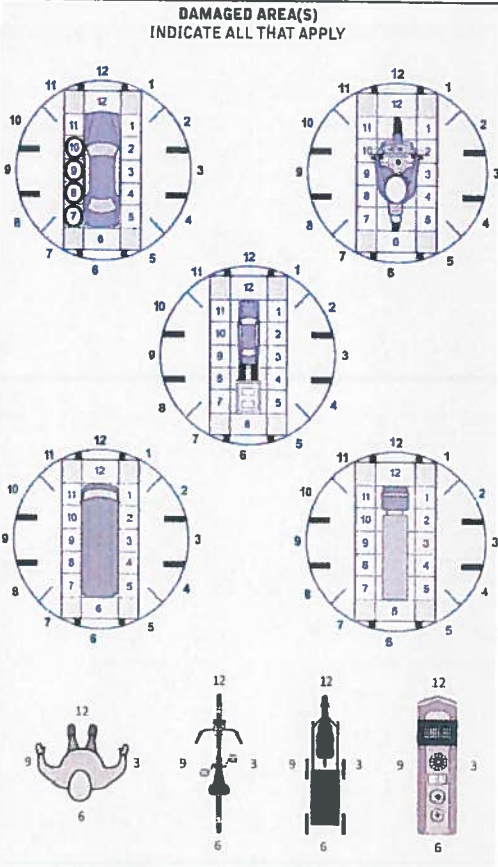
