1. Donation from the American Legion Portage Post #496(Draft #15 - 110)

4. Acceptance of a FEMA Grant for Fire Department (Draft #15 - 111)

Information Items

1. Fire Incident Report

Chief Tosko has provided a copy of the fire and emergency medical services report for May 2015. In 2015 calls for fire service are down 6% (20 calls); fire mutual aid assistance is up 4 events in 2015; and EMS responses are up 4% (54 calls). (attachment)

3. Draft Ordinance 15-122: Position Allocation Amendment
