### **ORDINANCE NO. 2022-023**

AN ORDINANCE ACKNOWLEDGING THE NORTHERN JURISDICTIONAL BOUNDARY RECORDED ON THE TAX MAP FOR THE ANNEXATION OF TERRITORY PETITION PASSED BY THE COUNCIL OF THE VILLAGE OF KENT, OHIO, ON THE 26<sup>TH</sup> DAY OF NOVEMBER 1917 DOES NOT ALIGN WITH THE LEGAL DESCRIPTION OF THE 1917 PETITION AND TO CORRECT THE ERROR, CITY OF KENT AFFIRMS THE NORTHERN JURISDICTIONAL BOUNDARY IS THE CENTER OF THE CUYAHOGA RIVER AND PARCEL 12-050-00-01-010 AND PARCEL 12-050-00-012-000, CURRENTLY RECORDED BY PORTAGE COUNTY IN THE BOUNDARY OF FRANKLIN TOWNSHIP, ARE WITHIN THE JURISDICTIONAL BOUNDARY OF THE CITY OF KENT; AND DECLARING AN EMERGENCY.

WHEREAS, the legal representative for the property owner of Parcel 12-050-00-00-011-000 and Parcel 12-050-00-00-012-000 contacted the City of Kent and Franklin Township regarding an error on the northern jurisdictional boundary of the 1917 tax map recorded for the "Annexation of Territory Petition" dated the 26<sup>th</sup> day of November 1917; and

WHEREAS, the legal description of the "Annexation of Territory Petition," dated the 26<sup>th</sup> day of November 1917, specifies the center of the Cuyahoga River as the northern jurisdictional boundary line for the Village of Kent, but the tax map actually places the northern jurisdictional boundary south of the Cuyahoga River; and

WHEREAS, the City acknowledges the tax map recorded in 1917 does not accurately depict the northern jurisdictional boundary, as specified in the legal description of the "Annexation of Territory Petition," dated the 26<sup>th</sup> day of November 1917; and

**WHEREAS**, the City agrees with the property owner of Parcel 12-050-00-00-011-000 and Parcel 12-050-00-00-012-000 the northern jurisdictional boundary, as specified in the "Annexation of Territory Petition," dated the 26<sup>th</sup> day of November 1917, is in the center of the Cuyahoga River, which situates the parcels within the jurisdictional boundary of the City of Kent.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Kent, Portage County, Ohio, that:

<u>SECTION 1.</u> Kent City Council does hereby affirm the northern jurisdictional boundary specified in the "Annexation of Territory Petition" dated the 26<sup>th</sup> day of November 1917, is the center of the Cuyahoga River and that Parcel 12-050-00-01-000 and Parcel 12-050-00-00-012-000, all attached hereto as Exhibit A, are within the jurisdictional boundary of the City of Kent.

**SECTION 2.** it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

<u>SECTION 3</u>. this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the residents of this City, for which reason and other reasons manifest to this Council, this Ordinance is hereby declared to be an emergency measure and shall take effect and be in force immediately after passage.






