Firehouse Subs donates nearly \$55,000 in equipment to three local departments

MAYFIELD HEIGHTS, Ohio -- Nearly \$55,000 in equipment donations by a flagship sandwich shop will go a long way in helping three fire departments continue their mission of protecting the public and saving lives.

Representatives from Firehouse Subs presented the gear on April 9 at their Mayfield Heights restaurant to firefighters



in Cleveland Heights, Mayfield Heights and Maple Heights.

The Cleveland Heights Fire Department received close to half of that amount, with over \$26,000 awarded for seven sets of individual turnout gear, including self-contained breathing masks, lights, hoods and boots.

Fire Chief Dave Freeman noted that the masks all have to be individually fitted, and with 11 new firefighters hired since February -- most of those on a FEMA grant -- the department was already falling

behind on its equipment replacement rotation.

"The only way we're going to be able to do that is if we get some help," Freeman noted. "Like every city, we're cutting back as much as we can. It's difficult, but this helps us a lot, especially in our uniform budget."

Mayfield Heights Fire Chief Bruce Elliott's grant application focused on public education, and for that, the department received over \$13,000, primarily to buy a "hazard house" simulator.

It looks like a giant doll house, but that's only until all hell breaks loose with smoking stairwells, electrical wires that "arc" and cause imitation fires, and problems with gas-operated appliances.

The interactive scale model folds up into a case that can be wheeled into schools and community centers. And it's not

cheap -- costing over \$10,000.




"We've built up a solid education program, and public awareness truly does make for a safer community," Elliott said, noting that statistics from the State Fire Marshal's Office show that the number of fire deaths has gone down over the last three years.

"And we believe the main reason for that is public education," Elliott said.

"By reaching out to the schools and by getting the word out to young people, we can save lives."

PROJECT DESCRIPTION:

The applicant is to construct a three story mixed use building consisting of commercial space on the ground floor and two stories of residential use. Each residential floor will consists of 2-2 bedroom apartments. Due to the topographic change in the parcel, the second floor (1st floor of apartments) will be accessible from ground level.

TRAFFIC/PARKING:

Off street parking is not required in the C-D District. The applicant to provide a parking plan for residents and employees. The current site, which also consists of mixed use commercial and residential, has an 8 space paved area within the street right-of-way but outside of the travel lanes on Portage Street. The plan is to continue to utilize these spaces for the residential units. The commercial use will utilize the on-street public parking. There is an area for a loading zoning on the property east of the building for the residential.

UTILITIES:

Public utilities are available for connections.

STORMWATER:

Little additional impervious area is proposed. Hence, storm water management is not required. However, the applicant will still need to submit calculations demonstrating this is the case.

SIGNAGE:

No signage is proposed at this time.

LIGHTING/LANDSCAPING/DUMPSTER:

Lighting will consist of low wattage building light fixtures. A photometric plan will need to be submitted during the technical review stage of this project. No additional landscaping is proposed. The dumpster will be within the trash enclosure located behind the building (east side) adjacent to the loading/unloading zone, which will be wheeled out to Portage Street for collection.

ARCHITECTURAL ADVISORY BOARD:

The project will be reviewed by the Architectural Review Board on June 16, 2015. Staff will report on the results at the meeting.

VARIANCES:

No variances are required at this time.

RECOMMENDATION:

Staff is recommending that the Planning Commission approve the conditional zoning certificate and site plan with the conditions listed below.
