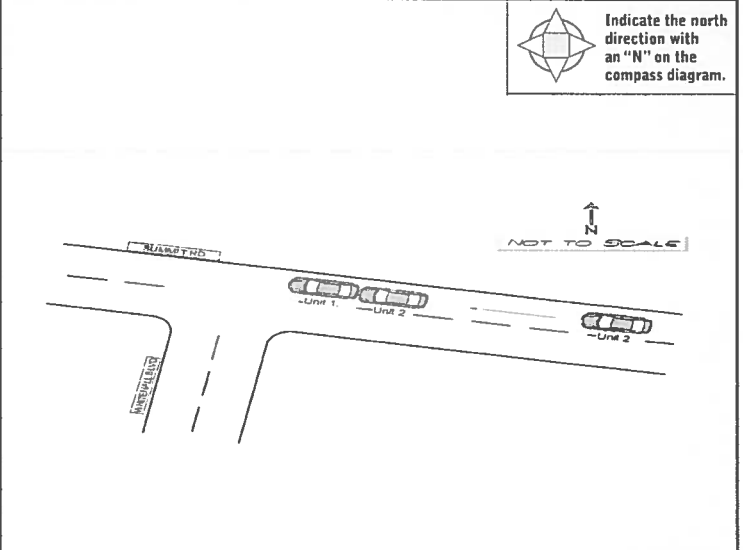

NARRATIVE

Unit 1 was stopped in the roadway on Summit Rd. facing west bound waiting for traffic to clear so it could make a left hand turn onto Whitehall Blvd. Unit 2 was traveling west bound on Summit Rd. behind Unit 1. Unit 2 failed to come to a complete stop in time and struck Unit 1 in the rear causing damage to both vehicles.
