

ORDINANCE NO. 2024 -088

**AN ORDINANCE AUTHORIZING THE WATER TAP-IN FOR PETROS DEVELOPMENT GROUP FOR THE PROPERTY LOCATED AT 2567 STATE ROUTE 43, OUTSIDE THE CITY OF KENT, AND DECLARING AN EMERGENCY.**

**WHEREAS**, Petros Development Group requests water service outside the City of Kent for property located at 2567 State Route 43, State Route 59 located in Brimfield Township (the "Property"); and

**WHEREAS**, the Property is within the Kent-Brimfield JEDD Contract area and the owner did sign the contract, therefore, the Property is NOT subject to a 50% water surcharge; and

**WHEREAS**, the City Division of Engineering recommends approving the water tap-in.


**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Kent, Portage County, Ohio:

**SECTION 1:** That Kent City Council does hereby authorize the water tap-in to the Property subject to KCO 913.09 and the City water rules and regulations.

**SECTION 2.** That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

**SECTION 3.** That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of the residents of this City, for which reason and other reasons manifest to this Council this Ordinance is hereby declared to be an emergency measure and shall take effect and be in force immediately after passage.
